Important Notes

The City of St. James has adopted the 2015 ICC Building Codes as well as 2014 NEC (Electric Code). All construction must conform to any and all City Codes. All permits must be paid in full before issuance. Utility tap fees, utility deposits and road excavation permits must be paid in full before connection of any utilities. If a new water or sewer tap is needed, there is a \$50 per tap fee plus cost of materials. If the water or sewer main is located in a public right of way such as a street, a street excavation permit must be obtained along with a \$100 non-refundable fee and a \$500 refundable deposit per cut. All applications submitted must, at the very least, include a sketch drawing of a picture of the lot from the County GIS. Some applications may require engineered plans. Each primary structure must be placed on a single lot without crossing lot lines. Please schedule footing/foundation inspections 24 hours in advance. Failure to meet these requirements may result in a Stop Work Order and or a fine(s) as outlined in the regulations and ordinances of the City of St. James.

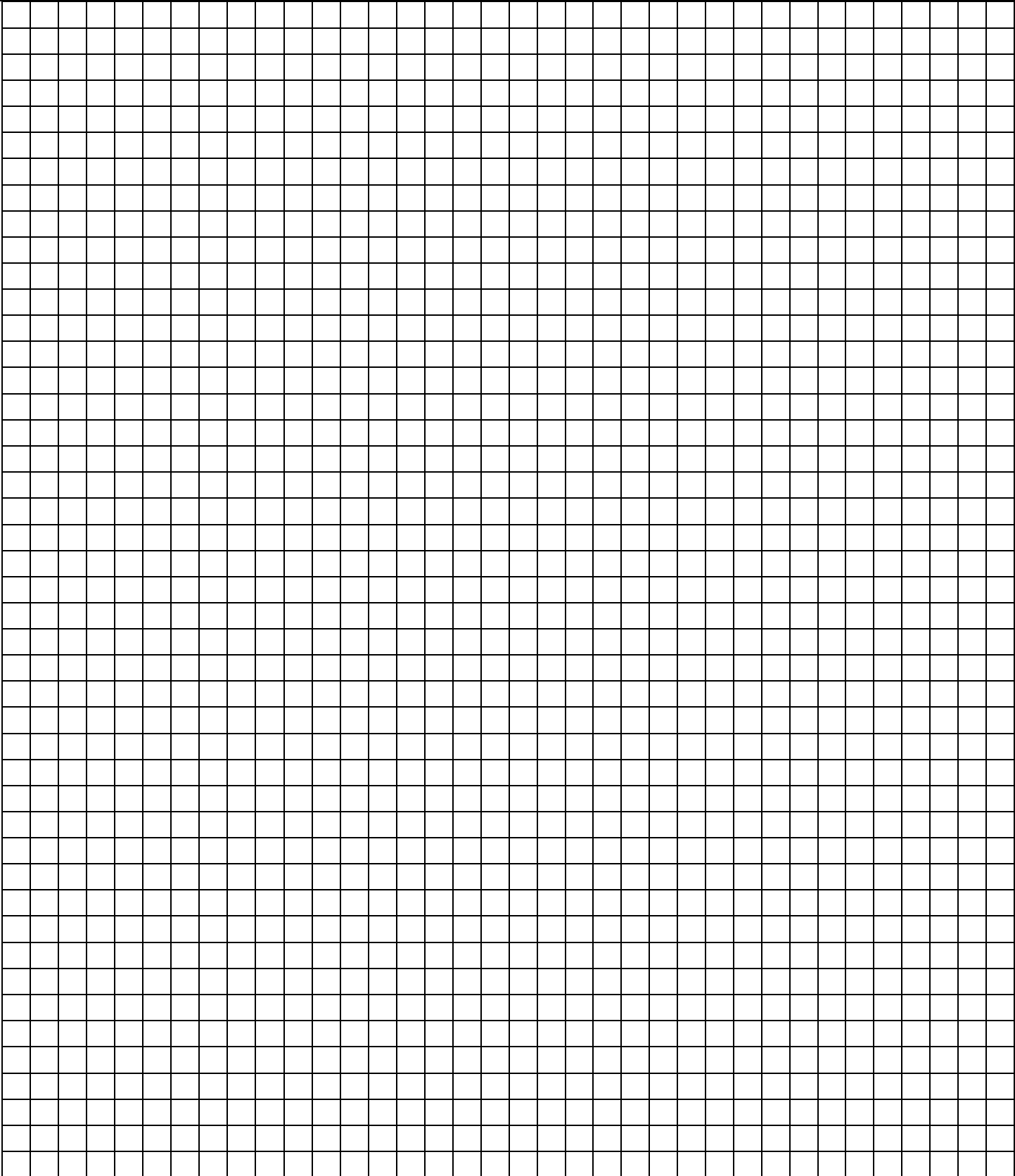
